ECGC Ltd. is a Public Sector enterprise, wholly owned by the Government of India, with the objective of promoting exports from the country by providing credit risk insurance and related services for exports.

ECGC Ltd. invites applications from eligible candidates for the post of Probationary Officer in the cadre of Executive Officer (Generalist and Specialist) in the pay scale of ₹ **88,635-4385(14)-150025-4750(4)-169025**. The appointed officers shall also be eligible for applicable allowances and benefits viz. Dearness Allowance, House Rent Allowance / House Lease Reimbursement, Transport Allowance, Medical Allowance, Newspaper Allowance, Meal coupons, Reimbursement of Mobile Bills, Mobile Handset and Briefcase Allowance, Furniture Allowance, Household help Allowance etc. The current CTC (Cost to Company) of Executive Officer (Probationary officer) posted in Mumbai is approximately ₹20,00,000/- (in words Rupees Twenty Lakh only) per annum.

Applicants desirous of securing job at ECGC are hereby cautioned not to fall prey to any unscrupulous elements who may try to deceive candidates/public by false promises of securing jobs in ECGC. The Recruitment Process consists of Online Examination followed by interview of the candidates shortlisted on the basis of their performance in the online examination. The online examination for the selection of personnel for the post of Probationary Officer is scheduled on 11.01.2026(tentatively). An eligible candidate who aspires to join ECGC Ltd. as a Probationary Officer is required to register for the Recruitment Process.

Candidates shortlisted based on the online examination shall be called to Delhi/ Mumbai for an interview; details thereof shall be communicated to the shortlisted candidates at a later stage. The recruitment will be strictly in line with the spirit of Government's guidelines on Reservation.

#### **A. ELIGIBILITY CRITERIA**

Candidates, intending to apply for the Recruitment Process should ensure that they fulfill the minimum eligibility criteria specified in this advertisement:

Please note that the eligibility criteria specified herein are the basic criteria for applying for the post. Candidates must necessarily produce the relevant documents in original and a photocopy in support of their identity and eligibility-pertaining to category, nationality, age, educational qualifications etc. as indicated in the online application form at the time of interview and at any subsequent stage of the recruitment process as may be required. Please note that **NO** change of category will be permitted at any stage after registration of the online application and the result will be processed considering the category which has been indicated in the online application, subject to guidelines of the Government of India in this regard. Merely applying for the Recruitment Process/appearing for and being shortlisted in the Online Examination and/or in the subsequent interview and/subsequent processes does not imply that a candidate will necessarily be offered employment in the Company. No request for considering the candidature under any category other than the one in which one has applied will be entertained.

- I. Nationality / Citizenship: A candidate must be either –
- (i) a Citizen of India or
  - (ii) a subject of Nepal or
  - (iii) a subject of Bhutan or
  - (iv) a Tibetan Refugee who came over to India before 1<sup>st</sup> January 1962 with the intention of permanently settling in India or
  - (v) a person of Indian origin who has migrated from Pakistan, Myanmar, Sri Lanka, East African countries of Kenya, Uganda, the United Republic of Tanzania (formerly Tanganyika and Zanzibar), Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India provided that a candidate belonging to categories (ii), (iii), (iv) & (v) above shall be a person in whose favor a certificate of eligibility has been issued by the Government of India.

**NOTE:**

(i) Relaxation of 13 years for PwBD (OBC) where vacancies are reserved for OBC candidates. Relaxation of 15 (fifteen) years for PwBD (SC/ST) candidates where vacancies are reserved for SC/ST candidates. The relaxation in upper age limit to SC/ST/OBC candidates is allowed on cumulative basis with only one of the remaining categories for which age relaxation is permitted as mentioned above in Point No. II (3) to II (4).

(ii) The maximum age limit specified is applicable to General Category candidates and Economically Weaker Section (EWS) Category Candidates.

(iii) Candidates seeking age relaxation will be required to submit necessary certificate(s) issued by Competent Authority in the prescribed format as stipulated by Government of India in original along with photocopies at the time of Interview and at any subsequent stage of the recruitment process as required by ECGC Ltd. The prescribed format of the certificates is annexed with the Notification. However, the same are subject to amendment from time to time as per Government guidelines.

(iv) In case of candidates belonging to OBC category, certificate should specifically contain a clause that the candidate does not belong to creamy layer section which is excluded from the benefits of reservation for Other Backward Classes in Civil post & services under Government of India. Candidates belonging to OBC category but coming under creamy layer are not entitled to OBC reservation. They should indicate their category as General in the online application form. The candidate should possess a valid OBC certificate with a Non-Creamy layer clause as per the Government of India Guidelines, issued from time to time.

(v) If an ex-serviceman applies for various vacancies before joining any civil employment, he/she can avail the benefit of reservation as ex-serviceman for any subsequent employment. However, to avail this benefit, an ex-serviceman as soon as he/she joins any civil employment, should give self-declaration/ undertaking to the concerned employer about date-wise details of application for various vacancies for which he/she had applied for before joining the initial civil employment. Further, this benefit would be available only in respect of vacancies which are filled on direct recruitment and wherever reservation is applicable to the ex-serviceman. There is no reservation for Ex-servicemen in Officers' Cadre.

**III. Minimum Educational Qualification (as on 01.11.2025):**

**A. For Probationary Officers (Generalists)**

Bachelor's Degree/ Graduate in any discipline from a University recognized by the Government Of India or any equivalent qualification recognized as such by the Central Government. The candidate must possess valid Mark-sheet / Degree Certificate that he/ she is a graduate on the day he / she registers and indicate the percentage of marks obtained in Graduation while registering online.

**Note: (i) All the educational qualifications mentioned should be from a University/ Institution/ Board recognized by the Government of India/ approved by Government Regulatory Bodies and the final result should have been declared on or before 01.11.2025.**

**Proper document from Board / University/ Institution for having declared the result on or before 01.11.2025 has to be submitted at the time of interview.** The date of passing the eligibility examination will be the date appearing on the mark-sheet or provisional certificate issued by University / Institute. In case the result of a particular examination is posted on the website of the University / Institute and web-based certificate is issued then proper document/certificate **in original** issued and signed by the Appropriate Authority of the University / Institute indicating the date of passing properly mentioned thereon will be reckoned for verification and further process.

(ii) Candidate should indicate the percentage obtained in Graduation calculated to the nearest two decimals in the online application. Wherever CGPA (Cumulative Grade Points Average) / OGPA (Overall Grade Point Average) is awarded, the same should be converted into percentage as per criteria adopted by the University/ Institute and indicated in online application. If called for interview/document verification, the candidate will have to produce a certificate issued by the Appropriate Authority inter alia stating that the norms of the University regarding conversion of grade into percentage and the percentage of marks scored by the candidate in terms of norms.

(iii) **Calculation of Percentage:** The percentage of marks shall be arrived at by dividing the total marks obtained by the candidate in all the subjects in all semester(s)/year(s) by aggregate maximum marks (in all the subjects irrespective of honors / optional / additional optional subject, if any) multiplied by 100. This will be applicable to those Universities also where Class / Grade is decided on the basis of Honors marks only. The fraction of percentage so arrived will be ignored i.e., 59.99% will be treated as less than 60% and 54.99% will be treated as less than 55%.

#### IV. **Reservation for Persons with Benchmark Disabilities**

Under section 34 of “The Rights of Persons with Disabilities Act, 2016” (RPwD Act), persons with benchmark disabilities are eligible for Reservation. The posts are identified suitable for the Persons under categories of disabilities as defined in the Schedule of RPwD Act 2016 and notified by the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice & Empowerment from time to time.

##### **A. Orthopedically challenged/ Locomotor Disability (“OC”/ “LD” category):**

A person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both, including persons with Spine Injury (SI)/Spine Deformity (SD) with or without any associated neurological/limb dysfunction, Cerebral Palsy, Leprosy Cured, Dwarfism, Muscular Dystrophy and Acid Attack Victims. Orthopedically challenged persons are covered under locomotor disability provided independent mobility is not affected, with following bench mark, are eligible to apply:

- OA – One arm affected (Right or Left)
- OL – One leg affected (Right or Left)
- OAL- One arm and One leg affected
- BA- Both Arms

Persons with OA and OAL category should have normal bilateral hand functions.

a. "Leprosy cured person" means a person who has been cured of leprosy but is suffering from:

i. Loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eyelid but with no manifest deformity;

ii. Manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;

iii. Extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall be construed accordingly;

b. "Cerebral palsy" means a Group of non-progressive neurological conditions affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;

c. "Dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less;

d. "Muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterized by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;

e. "Acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.

**B. Visual Impairment (“VI” Category):** Only those Visually Impaired (VI) persons who suffer from any one of the following conditions, after best correction, are eligible to apply:

a. Blindness:

i. Total absence of sight; OR

- ii. Visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; OR
- iii. Limitation of the field of vision subtending an angle of less than 10 degree. OR
- b. Low Vision:
  - i. Visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; OR
  - ii. Limitation of the field of vision subtending an angle of less than 40 degree up to 10 degrees.

**C. Hearing Impaired ("HI" Category):**

- a. Deaf: means person having 70 DB hearing loss in speech frequencies in both ears.
- b. Hard of Hearing: means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears.

**D. 4<sup>th</sup> Category:** Only those persons, who suffer from any one of the following types of disabilities or multiple disabilities as defined below, are eligible to apply under this category:

**1. Intellectual disability.**

a. "Autism Spectrum Disorder" (ASD) means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviors.

b. "Specific Learning Disability" (SLD) means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia.

c. "Mental Illness" (MI) means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behavior, capacity to recognize reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterized by sub normality of intelligence.

2. "Multiple Disabilities" means multiple disabilities amongst clause "A"; "B"; "C"; D of (1)" above.

Note: Only those persons with benchmark disabilities would be eligible for reservation. "Benchmark Disability" means a person with not less than 40% of a specified disability where specified disability has not been defined in measurable terms and includes the persons with disability, where disability has been defined in a measurable term, as certified by the certifying authority.

A person who wants to avail benefit of reservation will have to submit the latest valid disability certificate/ Unique Disability Identity Card (UDID card) issued by the Competent Authority as per the Government of India guidelines. Such certificate will be subject to verification/ re-verification as may be decided by the Competent Authority of ECGC Ltd.

The allocation of reserved vacancies for the persons with benchmark disabilities will be as prescribed in the "The Rights of Persons with Disabilities Act, 2016" and as per vacancies by ECGC Ltd.

**(i) Guidelines for Persons with Benchmark Disabilities/ Specified Disabilities using a Scribe**

The visually impaired candidates and candidates who face functional limitations in writing an examination, irrespective of the nature or extent of their disability which includes but is not limited to, individuals with physical limitations in writing, visual impairments preventing reading or writing, intellectual disabilities affecting comprehension or expression, or any other disability that impedes their ability to participate effectively in examination process, as certified by a competent authority, can use their own scribe at their cost during the online examination.

The scribe will be allowed to be used as per the guidelines issued vide Office Memorandum F.No. 16-110/2003-DDIII dated February 26, 2013 by the Government of India, Ministry of Social Justice and Empowerment, Department of Disability Affairs, New Delhi and clarification issued by the Government of India, Ministry of Finance, Department of Financial Services vide letter F. No. 3/2/2013- Welfare dated 26.04.2013 and Office Memorandum F. No. 5 29-6/2019-DD-III dated 10.08.2022 issued by the Government of India, Ministry of Social Justice and Empowerment, Department of Empowerment of Persons with Disabilities (Divyangjan). In all such cases wherever a scribe is used, the following rules will apply:

- a. For candidates availing scribe in accordance with OM – F. No. 29-6/2019-DD-III dated 10.08.2022, shall be allowed scribe facility subject to production of a certificate at the time of online examination to the effect that person concerned has limitation to write and that scribe is essential to write examination on his/her behalf from the competent medical authority of a Government healthcare institution as per proforma attached as **Annexure-VIII**.
- b. Also, the qualification of the scribe should be one step below the qualification of the candidate taking examination. Letter of undertaking as per **Annexure-IX** should be submitted by such candidates at the time of examination.
- c. The candidate will have to arrange his/her own scribe at his/her own cost.
- d. The scribe may be from any academic stream.
- e. Both the candidate as well as scribe will have to give a suitable undertaking confirming that the scribe fulfils all the stipulated eligibility criteria for a scribe mentioned above. Further, in case it is later, at any stage, observed or comes to knowledge that he/she did not fulfil any laid down eligibility criteria or suppressed any information the candidature of the applicant will stand cancelled, irrespective of the result of the written exam.
- f. Deliberate wrong information about the candidate/ scribe in declaration form submitted at the time of online application or at the time of examination or at any stage would render the candidate and scribe being debarred either permanently or for a specified period of time for recruitment examinations of ECGC Ltd.
- g. During the exam, at any stage, if it is found that scribe is independently answering the questions, the exam session will be terminated and candidate's candidature will be cancelled. The candidature of such candidates using the services of a scribe will also be cancelled if it is reported after the examination by the test administrator personnel that the scribe independently answered the questions or prompted the answers in any direct/indirect manner. In such cases, the candidate and scribe may also be debarred either permanently or for a specified period from all recruitment examinations conducted by ECGC Ltd.
- h. Those candidates who use a scribe shall be eligible for compensatory time of 20 minutes or otherwise advised for every hour of the examination.
- i. A person acting as a scribe for one candidate cannot be scribe for another candidate.
- j. The Scribe should not be current/ex-employee of ECGC Ltd.
- k. **The scribe arranged by the candidate should not be a candidate for the online examination.**

- l. Candidates eligible for and who wish to use the services of a scribe in the examination should invariably indicate the same carefully in the online application form. Any subsequent request may not be favorably entertained.**
- m. Only candidates registered for compensatory time (at the time of online registration) will be allowed such concessions since compensatory time given to candidates shall be system based, it shall not be possible for the test conducting agency to allow such time if he / she is not registered for the same. Candidates not registered for compensatory time shall not be allowed such concessions afterwards.**
- n. Those candidates who have been debarred from appearing in ECGC examinations for a specified period in terms of communication made to that effect by ECGC may act accordingly.**
- o. ECGC Ltd. reserves the right to share the list of debarred candidates/ scribes to other Recruiting Agencies for their information.**
- p. Candidates are advised to possess/acquire valid Aadhaar Card for this recruitment process. ECGC Ltd. reserves the right to conduct Aadhaar verification of the candidate/ scribe at different stages of the selection process.**

**If violation of the above guidelines is detected at any stage of the process, candidature of the candidate and the scribe will be cancelled and they shall stand disqualified from the recruitment procedure and can be removed from the service without any notice, even if they have joined the Company.**

**(ii) Guidelines for candidates with locomotor disability and cerebral palsy**

A Compensatory time of twenty minutes per hour or otherwise advised shall be permitted for the candidates with locomotor disability and cerebral palsy where dominant (writing) extremity is affected to the extent of slowing the performance of function (minimum of 40% impairment).

**(iii) Guidelines for Visually Impaired candidates**

Visually Impaired candidates (who suffer from not less than 40% of disability) will be provided with the facility of viewing the contents of the test in magnified font and all such candidates will be eligible for compensatory time of 20 minutes for every hour or otherwise advised of examination.

The facility of viewing the contents of the test in magnifying font will not be available to Visually Impaired candidates who use the services of a Scribe for the examination.

**(iv) Guidelines for Candidates with Intellectual Disability (ID)**

A Compensatory time of twenty minutes per hour of examination, either availing the services of a scribe or not, shall be permitted to the candidates with more than 40% Intellectual Disability (autism, intellectual disability, specific learning disability and mental illness).

**(v) Guidelines for persons with specified disabilities having less than 40% disability and having difficulty in writing:**

Facility of scribe and/or compensatory time will be extended, if opted by persons with specified disabilities as per section 2 (s) of RPwD Act, 2016, not covered under section 2 (r) having less than 40% disability and having difficulty in writing. The facility of scribe and/or compensatory time shall be granted solely to those applicants having difficulty in writing subject to production of a certificate to the effect that person concerned has limitation to write and that the scribe is essential to write examination on his/her behalf from the competent medical authority of a Government healthcare institution as per proforma at Annexure-VIII. The eligible candidate is required to bring their own scribe. The qualification of scribe should be one step below the qualification of the candidate taking examination. For Specialist, eligible Candidates may bring a scribe with the

ability to communicate in Hindi. However, the discipline of the scribe is to be different from the discipline specified for the post.”

The person opting for own scribe should submit details of the own scribe as per proforma at Annexure-IX

A compensatory time of not less than 20 minutes per hour of the examination shall be allowed for persons who are eligible for getting scribe.

In case, the duration of the examination is less than an hour, then the duration of the compensatory time shall be allowed on pro-rata basis.

Persons who are not covered under the existing scheme of reservations to the Scheduled Castes, the Schedule Tribes and the Other Backward Classes and whose family has gross annual income below Rs.8.00 lakh (Rupees eight lakh only) are to be identified as EWSs for benefit of reservation. The income shall include income from all sources i.e., salary, agriculture, business, profession etc. and it will be income for the financial year prior to the year of application. Also, persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWSs, irrespective of the family income:

- i.) 5 acres of Agricultural Land and above;
  - ii.) Residential flat of 1000 sq. ft. and above;
  - iii.) Residential plot of 100 sq. yards and above in notified municipalities;
  - iv.) Residential plot of 200 sq. yards and above in areas other than the notified municipalities.
2. The property held by a "Family" in different locations or different places / cities would be clubbed while applying the land or property holding test to determine EWS status.
3. The benefit of reservation under EWS can be availed upon production of a valid 'Income and Asset Certificate' valid for Financial year 2025-26 issued by a Competent Authority. The Income and Asset Certificate issued by any one of the Authorities as notified by the Government of India in the prescribed format shall only be accepted as proof of candidate's claim as belonging to EWS. The candidates shortlisted for document verification/interview shall be required to bring the requisite certificate as specified by the Government of India at the time of appearing for the process of document verification/interview. No request for extension of time for production of "Income and Assets Certificate" beyond the said date shall be entertained.
4. The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse, and children below the age of 18 years.
5. The instructions issued by the Government of India in this regard from time to time shall be adhered to.

## VI. **ONLINE PRE-EXAMINATION TRAINING**

Online Pre-examination Training will be arranged by the Company for eligible candidates belonging to Scheduled Caste/Scheduled Tribes/Other Backward Classes (Non-Creamy Layer)/PwBD.

All eligible candidates who opt for and wish to avail of Online Pre-examination Training should fill in the relevant column in the ON-LINE APPLICATION. Depending on the response and administrative feasibility, the right to cancel the Online Pre-Examination Training is reserved.

By merely attending the Pre-Examination Training, no candidate acquires any right to be selected in the Company.

## B. **RECRUITMENT PROCESS –ONLINE EXAMINATIONS**

An online screening examination consisting of two papers (Multiple-Choice questions of 200 marks followed by a Descriptive Paper of 40 marks) will be held.

The Company has the right to modify the structure of the examination which will be intimated through its website. Other detailed information regarding the examination will be given in an Information Handout, which will be made available for the candidates to download along with the call letters from the Company's website [www.ecgc.in](http://www.ecgc.in)

There shall be a sectional cut-off and overall cut-off for the Online Examination. Marks of Descriptive Paper (English Language) will be reckoned for preparation of merit list. It will only be evaluated for those candidates who qualify in the Objective (MCQ) Test and are placed adequately high as per total marks in the objective test. The various qualifying cut off marks in each of the sections of the objective test and the descriptive paper will be decided by ECGC. Descriptive test to the extent of 12 times of the number of vacancies or more, in each category, subject to availability of qualified candidates as decided by the Company will be evaluated.

**Please note that the candidates will not be permitted to appear in the Online Examination without the following documents:**

- (1) Valid Call Letter for the respective date and session of Examination with a passport sized colored photo affixed on it.**
- (2) Photo identity proof (as specified) in original bearing the same name as it appears on the call letter/application form.**

- (ii) No request for change of center for examination shall be entertained.
- (iii) The Company, however, reserves the right to cancel any of the Examination Centres and/or add some other Centres, at its discretion, depending upon the response, administrative feasibility, etc. The intimation for the same will be provided to the candidates on their registered mobile number/e-mail/its website.

- (iv) The Company also reserves the right to allot the candidate to any Centre other than the one he/she has opted for.
- (v) Candidate will appear for the examination at an Examination Centre at his/her own risk and expenses and the Company will not be responsible for any injury or losses etc. of any nature.
- (vi) Any unruly behavior/misbehavior in the examination hall may result in cancellation of candidature/disqualification from this exam and also from future examinations conducted by the Company.

#### **D. Scores**

- I. The corrected scores obtained by each of the candidates in different sessions (if held) will be normalized using equi-percentile method. Scores up to two decimal points shall be taken for the purpose of calculations.

#### **II. Process for Arriving at Scores**

The Scores of Online Examination are obtained by adopting the following procedure:

- (i) Number of questions answered correctly by a candidate in each objective test is considered for arriving at the Corrected Score after applying negative marking for wrong answers.
- (ii) The Corrected Scores so obtained by a candidate are made equivalent to take care of the minor difference in difficulty level, if any, in each of the objective tests held in different sessions to arrive at the Equated Scores\*

\* Scores obtained by candidates on any test are equated to the base form by considering the Distribution of scores of all the forms.

- (iii) Test wise scores and scores on total is reported with decimal point upto two digits.

**Note:** Cutoffs are applied in two stages:

- i. on scores of each section of the Online Examination (including Descriptive Examination)
- ii. on Total Score

#### **III. Cut-off Score (Online Examination)**

Each candidate will be required to obtain a minimum score in each test of Online Examination and also a minimum total score to be considered to be shortlisted for interview. Depending on the number of vacancies available, cut-offs will be decided and candidates will be shortlisted for interview. Prior to the completion of the interview process, scores obtained in the Online Examination will not be shared with the candidates shortlisted for interview.

**MARKS OBTAINED IN THE ONLINE EXAMINATION WILL BE CONSIDERED FOR SHORTLISTING FOR INTERVIEW AND MARKS OBTAINED IN ONLINE EXAMINATION AND INTERVIEW TOGETHER WILL BE TAKEN FOR FINAL LISTING.**

#### **E. INTERVIEW**

Candidates who have been shortlisted through the Online Examination will subsequently be called for an interview to be conducted by the Company at Delhi or Mumbai. The Centre, address of the venue, time and date of interview will be informed to shortlisted candidates in their interview call letter. Candidates are required to download their interview call letters from the website of the Company, i.e. [www.ecgc.in](http://www.ecgc.in). Please note that no request regarding change in date, centre etc. of interview will be entertained. However, the Company reserves the right to change the date/venue/time/centre etc. of interview.

The total marks allotted for interview are 60. The minimum qualifying marks in interview shall not be less than 40% (35% for SC/ST/OBC/ PwBD candidates). The weightage (ratio) of Online Examination and interview will be 80:20 respectively. The combined final score of the candidates shall be arrived at on the basis of scores obtained by the candidates in the Online Examination and Interview. Interview score of the candidates failing to secure minimum qualifying marks or otherwise barred from the interview or further process shall not be disclosed.

A candidate should qualify both in the Online Examination and interview and should be sufficiently high in the merit list to be shortlisted for further selection process, details of which will be made available subsequently on the Company's website.

While appearing for the interview, the candidate should produce valid prescribed documents given below. In the absence of documents, candidature of the candidates shall be cancelled. Company takes no responsibility to receive/collect any certificate/remittance/document sent separately.

**List of Documents to be produced at the time of interview (as applicable)**

**The following documents in original and self-attested photocopies** in support of the candidate's eligibility and identity are to be invariably submitted at the time of interview failing which the candidate may not be permitted to appear for the interview. **Non-submission of requisite documents by the candidate at the time of interview will debar his/her candidature from further participation in the recruitment process.**

- (xiv) Any other relevant documents in support of eligibility.

- ii. **Non production of relevant eligibility documents at the time of interview shall make the candidate ineligible for further process of recruitment.**

#### F. Selection

Final selection shall be based on the performance and merit of the candidates in the Online Exam and Interview, taken together. On completion of the interview process, based on the business needs of the Company, candidates shortlisted will be issued joining letter based on merit keeping in view the spirit of Government Guidelines on reservation policy, various guidelines issued by Government of India/Others from time to time, administrative exigency, etc. Vacancies given in this advertisement are indicative as on the date of advertisement. However, the merit list of this Selection Process will be valid till one year (i.e. 365 days) from the date of publication of final result and any vacancies arising for the period up to **31.03.2026** may be filled by issuing the offer letters to the candidates based on it. The merit list will expire automatically one year (i.e. 365 days) after the publication of final result. The photo captured will be matched with the photo uploaded by the candidate in the application. Candidate must NOT change his/her appearance from the photo uploaded in the application. Refusal to

participate in the process of Biometric Thumb Impression, capture/verification on any occasion may lead to cancellation of candidature.

With regards to the biometric data capture, please note the following:

- a) If fingers are coated (stamped ink/mehndi/coloured. etc.), ensure to thoroughly wash them so that coating is completely removed before the exam day.
  - b) If fingers are dirty or dusty, ensure to wash them and dry them before the finger print (biometric) is captured.
  - c) Ensure fingers of both hands are dry. If fingers are moist, wipe each finger to dry them.
  - d) If the primary finger (Left thumb) to be captured is injured/damaged, immediately notify the concerned authority in the test centre.
- In such cases impression of other fingers, toes etc. may be captured.
