Subject: Head Constable (Ministerial) in Delhi Police Examination, 2025 – Declaration of result of Computer Based Examination for shortlisting candidates to appear in Physical Endurance & Measurement Test (PE&MT)/ Document Verification (DV)/ Trade Test (Skill Test).

The Staff Selection Commission conducted the Computer Based Examination for recruitment of Head Constable (Ministerial) in Delhi Police Examination, 2025 from 07.01.2026 to 12.01.2026 at various centres across the country.

2. The Computer Based Examination was conducted in multiple shifts; hence, marks scored by candidates have been normalized as per the formula published by the Commission vide Notice dated 02.06.2025. As per the provisions under Para 15.10 of the Examination Notice, normalized marks of the candidates have been used for processing the result to shortlist the candidates for the next stage of Examination [Physical Endurance & Measurement Test (PE&MT)/ Document Verification (DV)/ Trade Test (Skill Test)].

3. As per Para 17.4 of the Notice of Examination, minimum qualifying marks in Computer Based Examination (without adding NCC bonus marks) have been fixed as 40% for UR/EWS, 35% for SC/ST/OBC and 30% for Persons with Disabilities (PwD)/Ex-Servicemen (ESM) category candidates.

4. Based on the cut-off fixed by the Commission in CBE, the number of candidates qualifying for appearing in PE&MT/ DV/ Trade Test is as follows:

5. Bonus marks for NCC certificate holders and RRU Degree/diploma holders will be awarded in the final result to only those candidates who are able to produce supporting documents at the stage of PE&MT.

6. The result of the two (02) candidates bearing Roll Nos. 225240038486 and 225240267973 have been kept withheld due to suspected malpractice.

7. Based on the post-examination analysis, the following 51 (Fifty-One) candidates have been found indulging in malpractices in the CBE as per Para 31.2 of the Notice of Examination and Commission's Notice dated 10.09.2025 regarding warning and Advisory against Malpractices in Computer Based Examinations (CBE). Accordingly, the results of the following 51 (Fifty-One) candidates have not been processed due to their having indulged in malpractices

in the Examination. Aggrieved candidates are at liberty to represent their case before the concerned Regional Director.

The Final Answer Keys have been used for processing the results of CBE. The Final Answer Keys, along with Question Papers cum Response Sheets of CBE, as well as marks of the qualified/non-qualified candidates, will be uploaded on the website of the Commission in due course.
